PARTICIPANT RELEASE, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT SHERIDAN WYO RODEO

RELEASOR: (Participant Name) _____

RELEASEE: Sheridan Wyo Rodeo, Inc., Sheridan County, Sheridan County Fairground Association, and their directors, officers, agents, employees, commissioners, sponsors, related parties and volunteers (all hereinafter referred to as "RELEASEE").

Premises: Sheridan County Fairgrounds and all locations where RELEASEE conducts or sponsors RELAY RACING, and any type of rodeo, roping, racing, or livestock event, parade, campground, dancing, and any other activities associated with the Sheridan Wyo Rodeo and the World Championship Indian Relay Races.

The undersigned (herein referred to as "RELEASOR") requests permission to enter the grounds, arenas, barns, buildings, camp areas, parade routes, and all adjacent areas (herein referred to as "Premises") and to participate as a contestant, official, volunteer, spectator or otherwise in the World Championship Indian Relay Races, rodeo events, roping events, horse and livestock competition events, parades, dancing and all other activities conducted on the premises (herein referred to as "Activities"), and to be present on the premises as a participant or spectator while any such activities are going on.

In consideration of permission to participate in the activities and to enter the premises, RELEASOR, for him/herself and named minor children, does hereby state and agree:

I UNDERSTAND that entry on the premises and/or participation in the described activities contain DANGER AND RISK OF PROPERTY DAMAGE, BODILY INJURY OR DEATH TO RELEASOR; that conditions of the premises and activities change from time to time and may become more hazardous; that horses, livestock and other animals are dangerous and unpredictable; and that there is INHERENT DANGER in the activities conducted on the premises.

I ASSUME ALL RISKS connected with entry upon the premises and participation in any activity.

I RELEASE the above named RELEASEE from any and all claims and liability arising out of strict liability or ordinary negligence of RELEASEE or any other person, any hazards on the premises, or the use of any equipment or livestock that may be rented or borrowed, which causes the RELEASOR injury, death, damages or property damage, including injuries to horses or livestock.

I HOLD RELEASEE HARMLESS, COVENANT NOT TO SUE AND AGREE TO INDEMNIFY RELEASEE from any claim, judgment or expenses RELEASEE may incur arising out of the RELEASOR's activities or presence on the premises.

IF ACCOMPANIED BY A MINOR, I GRANT PERMISSION for said minor to participate and accompany me. I assume all responsibility for the conduct and safety of any said minor and for said minor's personal property. I release and hold harmless, and agree to indemnify RELEASEE from all liabilities of any kind arising out of negligence of RELEASEE or others, whether foreseeable or unforeseeable, which may cause said minor's bodily injury or death, or damage or loss to said minor's property.

PHOTOGRAPHIC RELEASE. I consent to being the subject of the photographs of RELEASEE, or any other person, together with any subject matter owned by RELEASOR, and authorize RELEASEE to cause the same to be exhibited, with or without advertising sponsorship, as still photos, transparencies, motion pictures, television, video or other similar media. I RELEASE all claims for damages for libel, slander, invasion of privacy, or any other claim based on use of the above described materials.

I REPRESENT that I am of lawful age and legally competent to sign this Release; that I understand that the terms of this Release are contractual; that this Release shall be binding on my personal representative or estate, assigns, heirs and next of kin; and AGREE that if any part of this Release is found not to be legally binding on me, all other parts of this Release shall be binding on me and continue in full force and effect.

I ACKNOWLEDGE that I have not been forced or coerced in any way to participate in this activity; that the activity described is not a service of a special or highly necessary nature for which RELEASEE owes a special duty to me or the public.

I AGREE that this Release shall remain in effect beginning on the above date AND FOR A PERIOD OF ONE YEAR THEREAFTER. All subsequent agreements and releases documents signed by the RELEASOR shall amplify, and shall in no way limit the provisions of this document.

I HAVE FULLY INFORMED MYSELF OF THE CONTENTS OF THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK BY CAREFULLY READING IT AND I HAVE SIGNED THIS RELEASE VOLUNTARILY.
